Subscribers can apply for NPS through the below mentioned routes:

- **Online Mode :** Subscriber can apply for NPS by simply logging on to [www.njindiaonline.com](http://www.njindiaonline.com) and fill up the online application form to enrol for the NPS Scheme.
- **Offline Mode :** Subscriber desirous to join NPS can visit nearest NJ India Invest Private limited Branch and submit the following documents along with the Subscriber Registration Form.
